SOFTWARE LICENSE AGREEMENT

ODIN Standalone Software



- §1. This is an agreement between Licensor and Licensee, who is being licensed to use the named Software. Licensor is Enguild Log Solutions AB (559390-6604), whose principal place of business is at Ögonmåttsgatan 1, SE-421 72 Västra Frölunda, Sweden. Phone +46 708 233933. The term "Software" includes all files contained in the installation kit for which this License is applicable. The installation kit is defined as any kind of software bundle, such as (but not limited to) a compressed library, a file, an executable installer, a CD/DVD containing files, etc. This license agreement is applicable to software used in computers or systems (containing multiple computers) where these computers are NOT part of a system utilizing an ODIN Security Log.
- **§2.** Licensee acknowledges that this is a non-assignable and only a limited non-exclusive license. Licensor is and remains the owner of all titles, rights, and interests in the Software. Licensee may not in any way (either by itself or with help from anyone else) copy, modify, create a derivative work of, reverse engineer, decompile or otherwise attempt to extract the source code of the Software or any part thereof, unless this is expressly permitted or required by law, or unless Licensee have been specifically granted to do this by Licensor, in writing. Licensee may make copies of the Software for backup purposes only.

Unless Licensor has given Licensee specific written permission to do so, Licensee may not assign (or grant a sublicense of) its rights to use the Software, grant a security interest in or over its rights to use the Software, or otherwise transfer any part of its rights to use the Software other than under the conditions stated in §3.

- §3. This License permits Licensee to install and use the Software on the number of computers specified in a Purchase agreement for the Software. The license is only valid for the time period specified in the Purchase agreement. The Licensee acknowledges that use of the Software beyond the date specified in the Purchase agreement is forbidden and the Software shall be uninstalled from all computers where it has been installed when the license expires unless a written exception from this rule is issued by the Licensor or a new Purchase agreement (for renewal) is in place. If a computer where the Software is installed is transferred to a third party, the license for the Software may also be transferred to a third party provided that the third party is made aware of the terms in this license and comply to all terms in this license. The Licensee is still responsible for renewal of the license and is responsible for enforcing fulfilment of the license towards the third party unless a Transfer agreement is established between the Licensor and the third party after which the third party becomes the new Licensee. To clarify, the original Licensee is responsible for payment of the license fee for renewal after the expiration date OR for providing a certificate of uninstallation of the Software unless a Transfer agreement is established.
- §4. This Software is subject to a limited warranty. Licensor warrants to Licensee that the physical medium on which this Software is distributed is free from defects in materials and workmanship under normal use, the Software will perform according to its printed documentation, and to the best of Licensor's knowledge Licensee's use of this Software according to the printed documentation is not an infringement of any third party's intellectual property rights. This limited warranty lasts for a period of 365 days after delivery. Delivery day shall be considered the day this License becomes effective according to §14. To the extent permitted by law, THE ABOVE-STATED LIMITED WARRANTY REPLACES ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, AND LICENSOR DISCLAIMS ALL IMPLIED WARRANTIES INCLUDING ANY IMPLIED WARRANTY OF TITLE, MERCHANTABILITY, NONINFRINGEMENT, OR OF FITNESS FOR A PARTICULAR PURPOSE. No agent of Licensor is authorized to make any other warranties or to modify this limited warranty. Any action for breach of this limited warranty must be commenced within one year of the expiration of the warranty. Because some jurisdictions do not allow any limit on the length of an implied warranty, the above limitation may not apply to this Licensee. If the law does not allow disclaimer of implied warranties, then any implied warranty is limited to 365 days after delivery of the Software to Licensee. Licensee has specific legal rights pursuant to this warranty and, depending on Licensee's jurisdiction, may have additional rights.
- §5. In case of a breach of the Limited Warranty, Licensee's exclusive remedy is as follows: Licensee will return all copies of the Software to Licensor, at Licensee's cost, along with proof of purchase (Signed Purchase or Transfer agreement). (Licensee can obtain a step-by-step explanation of this procedure, including a return authorization code, by contacting Licensor at the address stated in §1.) At Licensor's option, Licensor will either send Licensee a replacement copy of the Software, at Licensor's expense, or issue a full refund.
- **§6**. Notwithstanding the foregoing, LICENSOR IS NOT LIABLE TO LICENSEE FOR ANY DAMAGES, INCLUDING COMPENSATORY, SPECIAL, INCIDENTAL, EXEMPLARY, PUNITIVE, OR CONSEQUENTIAL



DAMAGES, CONNECTED WITH OR RESULTING FROM THIS LICENSE AGREEMENT OR LICENSEE'S USE OF THIS SOFTWARE. Licensee's jurisdiction may not allow such a limitation of damages, so this limitation may not apply.

- §7. Licensee agrees to defend and indemnify Licensor and hold Licensor harmless from all claims, losses, damages, complaints, or expenses connected with or resulting from Licensee's, or any third party to which the license is transferred, business operations.
- §8. This License will continue to apply until terminated by either the Licensor or Licensee as set out below. If Licensee want to terminate this License, Licensee shall do this in writing to Licensor (address given in §1). The Licensor may at any time, terminate this License if:
 - a) Licensee have breached any provision of the License (or have acted in manner which clearly shows that the Licensee do not intend to, or are unable to comply with the provisions of this License).
 - b) Licensor is required to do so by law (may be due to local changes in laws that are applicable to the Licensee or the Software). The license is in this case terminated immediately.
 - c) Licensee fails to renew the license, including payment in full according to the price list at the date of expiration for the purchase or transfer agreement.

Either party shall have the right to terminate the License effective immediately if the other party becomes the subject of bankruptcy, insolvency, liquidation or other similar institute event.

If not stated explicitly otherwise in any section of this License, termination of the License by either party shall be effective 30 days from the written notice of termination.

- **§9**. Licensee agrees to return to Licensor or to destroy all copies of the Software upon termination of the License and to uninstall it on all computers where it has been installed. The Licensee agrees to provide a certificate of uninstallation issued by a third party (approved by the Licensor) IF requested by the Licensor.
- **§10**. Any Confidential Information exchanged as a result of this License (during installation, support or execution of the software) between the Licensor and Licensee shall be protected and kept confidential by the other party with the same degree of care that it exercises with respect to its own Confidential Information. Confidential Information MAY NOT be disclosed to a third party without the written permission from the party that owns the Confidential Information.
- §11. This License Agreement together with the Purchase agreement OR Transfer agreement is the entire and exclusive agreement between Licensor and Licensee regarding this Software. This License Agreement together with a Purchase/Transfer Agreement replaces and supersedes all prior negotiations, dealings, and agreements between Licensor and Licensee regarding this Software.
- **§12**. The Licensee is eligibile for all updates of the Software within the time period of the Purchase agreement without any extra cost. Effective start date of the License agreement is stated in the Purchase agreement.
- §13. This License Agreement is governed by the law of Sweden. All disputes regarding this License shall be settled by arbitration in accordance with the Rules of the Arbitration Institute of the Stockholm Chamber of Commerce. The seat of arbitration shall bbe Stockholm, Sweden. The language used in the proceedings shall be Swedish or English.
- **§14**. This License Agreement is NOT valid without Licensor's signature. It becomes effective upon the delivery of Purchase or Transfer agreement signed by the Licensor.
